NZTA has not been provided with a list of words, terms or phrases that are not to be used in its communications or meetings.

As such, this part of your request is refused under section 18(e) of the Act as the document alleged to contain this information does not exist.

2. A list of all directions to officials regarding the length, style or make up of all briefings, letters, emails, memos, aides-memoires or any other documents.

NZTA has not received any direction regarding the formatting and style of its written correspondence.

As such, this part of your request is refused under section 18(e) of the Act as the document alleged to contain this information does not exist.

3. A copy of any style guide given to officials by the Minister's Office.

NZTA has not been provided with a style guide from the Minister's Office.

4. What directions, if any, has the Minister or their Office given to officials regarding the use of the word "equity"?

NZTA has not received any direction from the Minister or the Minister's Office regarding the use of the word 'equity'.

For context, the Minister requested NZTA plan to give effect to the National and New Zealand First Coalition Agreement to ensure all public service departments have their primary name in English, except for those specifically related to Māori. Accordingly, NZTA has taken a staged approach to the name changes, with the first phase including name changes in templates and briefings. Further changes, such as rebranding official websites etc, are awaiting all-of-government guidance to fully understand the extent of the requirements.

8. What directions, if any, has the Minister or their Office given to officials regarding the use of pronouns?

NZTA has not received any direction from the Minister or the Minister's Office regarding the use of the word 'pronouns'.
