3. Model

State the manufacturer's designation (eg Corolla, Commodore) - not the year of manufacture.

4. Identification

Driver licence - private individuals should enter their driver licence number.

Customer number - corporate organisations (non-individual) may have an NZ Transport Agency customer number allocated to them which is to be entered as identification.

Other - Individuals - if a driver licence number is not available, then photocopies of documents providing proof of full name, date of birth and signature (for example passport, firearms licence) must be provided with this completed form.

Corporate organisations - if a customer number has not been allocated then a photocopy of the *Certificate of incorporation* must be provided with this completed form.
