Request made under the Official Information Act 1982

Thank you for your email of 30 January 2023 requesting the following information under the Official Information Act 1982 (the Act):

- All correspondence internally about Waka Kotahi/NZTA's public communications during the Auckland floods on January 27 and 28. This should include any correspondence between staff about the need for public communication, when to start and finish communicating with the public, any discussion about social media updates, and any discussion of about criticism of Waka Kotahi/NZTA communications.
- All communication plans or guides devised, drafted or used on January 27 and 28 with regards to the Auckland floods
- All correspondence Waka Kotahi/NZTA staff had with ministers (and their offices) including the Transport Minister – and Auckland Council about public communications on January 27 and 28
- How many Waka Kotahi/NZTA staffers were working on communications related to the Auckland floods on January 27 and 28. If this fluctuated by hour (i.e -3 workers and 4pm, 5 workers at 8pm), can this please be broken down hour-by-hour.

Your request was extended for an additional 20 working days on 24 February 2023 as allowed for under section 15A of the Act due to the large quantity of information in scope of your request, and the consultation necessary to make a decision on your request meaning that a proper response could not reasonably be made within the 20-working day limit.

Waka Kotahi NZ Transport Agency acknowledges that there was a three-hour delay in social media communications during the January 2023 storm event. During this time, all other operations required to manage the event continued, including Journey Planner which is continuously updated with the latest information on road closures.

We know that the public needs accurate, reliable and up-to-date information as quickly as possible in situations such as the recent flooding events, and we are sorry that we did not meet these

expectations. A review into this has been undertaken, and extended levels of services have been agreed for future red events.

Correspondence and documents sent and received by Waka Kotahi and the office of the Minister of Transport

The documents in scope of your request are outlined in the attached document schedule and are enclosed in a combined document. In order to provide you with a complete overview of communications sent and received relating to the Auckland Anniversary weekend flooding events, we have included documents sent and received by the office of the Minister of Transport from agencies other than Waka Kotahi NZ Transport Agency.

Some information in these documents has been withheld under the following sections of the Act:

- Section 9(2)(a) to protect the privacy of natural persons, including that of deceased natural persons
- Section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank
 expression of opinions by or between or to Ministers of the Crown or members of an
 organisation or officers and employees of any department or organisation in the course of their
 duty

Information that is not in scope of your request has been redacted as out of scope.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

Recollection of phone calls and call logs

Due to the amount of phone calls that were made and received by key Waka Kotahi staff over the course of the flooding events, call log records have automatically been deleted by the phone providers, and are unable to be provided to you in this response. The emails and documents that have been provided to you with this response are aligned with any discussion that would have occurred through a phone call during the flooding events.

The Minister of Transport spoke to the Waka Kotahi Board Chair and acting Chief Executive via phone call on Friday 27 January 2023. The purpose of these calls was to discuss concerns with the lack of communications on Waka Kotahi social media channels, and to ask for these to be reinstated.
