Request made under the Official Information Act 1982

Thank you for your email of 23 February 2023 requesting the following information under the Official Information Act 1982 (the Act):

- Information relating to any communications, information and/or meetings between NZTA and KiwiRail regarding the road closure at the level railway crossing at the southern end of Telephone Road on State Highway 1B east of Hamilton; since 1 January 2022.
- Information relating to any communications, information and/or meetings between NZTA and Waikato District Council regarding the road closure at the level railway crossing at the southern end of Telephone Road on State Highway 1B east of Hamilton; since 1 January 2022.
- Information relating to any consultation that NZTA has undertaken, or will undertake, with the local community regarding the road closure at the level railway crossing at the southern end of Telephone Road on State Highway 1B east of Hamilton; since 1 January 2022.

On 7 March 2023, you agreed to refine your request to the date range 1 March 2022 to 30 April 2022. On 4 April 2023, we wrote to you to advise of a 10-working day extension to the timeframe for response under the Act. On 19 April 2023, we wrote to confirm a decision on your request and committed to provide you with the documents without undue delay.

I will address each part of your request in turn.

- Information relating to any communications, information and/or meetings between NZTA and KiwiRail regarding the road closure at the level railway crossing at the southern end of Telephone Road on State Highway 1B east of Hamilton; since 1 January 2022.
- Information relating to any communications, information and/or meetings between NZTA and Waikato District Council regarding the road closure at the level railway crossing at the southern end of Telephone Road on State Highway 1B east of Hamilton; since 1 January 2022.

A total of 29 documents have been identified as within the scope of these parts of your request. The documents (1 to 29) are listed in the document schedule appended to this response. These documents are released subject to the withholding of some information under section 9(2)(a) of the Act, in order to protect the privacy of natural persons.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

 Information relating to any consultation that NZTA has undertaken, or will undertake, with the local community regarding the road closure at the level railway crossing at the southern end of Telephone Road on State Highway 1B east of Hamilton; since 1 January 2022.

Four documents have been identified as within the scope of this part of your request (refer documents 30 to 33 of the document schedule). These documents are released to you in full.

These documents relate to the invitation for feedback and public drop-in session held on 27 June 2022. The invitation letter was dropped in mailboxes and emailed to the contact list for this project. The A0 boards were presented at the drop-in session. Approximately 150 people attended the drop-in session and 70 post-it notes with feedback were received along with spoken feedback heard by Waka Kotahi representatives at the event. Feedback was collated in the Summary of Engagement Sentiment document (refer document 32 in schedule). The project team met after the public event to discuss the feedback collated and team members shared feedback that had been given orally.

Under section 28 of the Act, you have the right to ask the Ombudsman to review my decision on this request. The contact details for the Ombudsman can be located at www.ombudsman.parliament.nz.

In line with Waka Kotahi policy, this response will soon be published on our website, with personal information removed.
