Thank you for your email of 15 May 2023 requesting the following information under the Official Information Act 1982 (the Act):

Waka Kotahi has 166 passenger vehicles in our fleet as at 30 April 2023

Q3 How many are hybrid or plug-in hybrid electric vehicle (HEV/PHEV)?

We have nine Plug In Hybrid (PHEV) vehicles in the Waka Kotahi fleet as at 30 April 2023

Q5 How many of these are battery-powered electric vehicle (BEV)?

We have 81 battery electric vehicles (BEV) in our fleet as at 30 April 2023

Q7 How many internal combustion engine vehicles (ICE) do you have?

We have 76 Internal combustion engine vehicles (ICE) in our fleet as at 30 April 2023

Q8 How many diesel or petrol utility vehicles do you have?

We have 34 diesel utility vehicles (utes) in our fleet of 166 passenger vehicles, at 30 April 2023
