









NTS Programme Executive Summary

Work on the delivery of phase 1 is progressing to the agreed plan. The technical design is almost complete and is expected to be signed-off by the end of August 2023.

The financial services provider Master Services Agreements (MSA), Transit Card Programme Manager (Mastercard) and Merchant Acquirer (ASB), have now been executed by all parties. This is the final step to the NTS Participation Agreement between Waka Kotahi NZ Transport Agency and the Public Transport Authorities being unconditional, although we have been operating under the terms of the Agreement since October 2022.

Testing on the two brands short-listed at the last NTS Governance Board meeting is progressing well and we expect to have the testing completed by the end of August 2023 and a final decision by September/October 2023.

Work is progressing with Greater Wellington Regional Council (GW), section 9(2)(j) Environment Canterbury (Ecan) to transition onto the NTS.

Budget is green (better)

The overall budget is not at risk. The Phase 1 integrated plan budget (to end of October 2024) has been endorsed by the NTS Governance Board and therefore the RAG status has been improved to green.

Schedule is amber (same)

We continue to refine the Phase 1 integrated plan. Getting appropriate resources onboarded in a timely fashion could still pose a risk to the delivery of the solution but this is being managed closely. We continue to review and ensure there is adequate contingency in the relevant parts of the plan.

Communications, media & engagement

Communications and Engagement

- There has been some media activity from Radio New Zealand (RNZ) recently as a result of a proactive release of an OIA request related material. The OIA was from GTS/Thales (OIA-12109, published on 31 July 2023 www.nzta.govt.nz/about-us/official-information-act/official-information-act-responses/) and focused on documents relating to the procurement phase of the programme from early 2022. The media report questioned Auckland Council commitment to the NTS programme. Subsequently, we, along with Auckland Transport, have met with Auckland Councillor Maurice Williamson and briefed him on the NTS section 9(2)(g)(i)

 RNZ has also requested additional information on governance matters and this is being provided to them as an OIA.
- We continue to receive limited number of OIAs primarily focused on the procurement process for selecting the NTS system supplier. We are currently working through the OIA from RNZ mentioned above.

lwi/Māori Engagement

We have two focus Areas for Iwi/Māori engagement:

- Issues/Opportunities related to payment methods for public transport.
- Issues/Opportunities related to the collection, storage and use of iwi/Māori customer data.

Initial feedback from our engagements is generally positive but we await a greater sample before drawing final conclusions and adapting the NTS Programme, as required. A full report is due to the Governance Board in September 2023.
