## **Request made under the Official Information Act 1982**

Thank you for your email of 13 February 2024 requesting the following information under the Official Information Act 1982 (the Act):

RNZ requests release in full of the following related to this in the BIM "The scale of change and investment in the rail space has considerably increased the risk profile of rail with more risk of interface issues on the rail networks and competing demands between freight and passenger rail service"

- Any and all briefings and advisories and memos and reports of any kind to any Minister in the govt voted in in Oct 2023
- The most substantive internal guiding document of any type that exists that details the risks noted above
  - Ditto re current state of the rail space (may be same doc as above)
  - o Ditto, for the options of what to do about that
- Details of any and all current recommendations that are 'live'/being considered for changes re rail space risks
- Any and all correspondence and comms including electronic and whatsapp between the 2 or 3 members of the NZTA exec most involved in this space, since Oct 1 2023, about the state of things/changes needed

I have numbered each part of your request for convenience and will answer each in turn.

## 1. Any and all briefings and advisories and memos and reports of any kind to any Minister in the govt voted in in Oct 2023

I am refusing this part of your request under section 18(e) of the Act because the documents alleged to contain the information requested do not exist.

 The most substantive internal guiding document of any type that exists that details the risks noted above

Ditto, for the options of what to do about that

The following documents fall within the scope of your request and are enclosed:

Please note that there is no definitive 'guiding document' that the NZ Transport Agency Waka Kotahi (NZTA) holds regarding rail risks. Please also note that Attachment 1 is a draft of a briefing that was never finalised due to its timing in relation to the General Election, some of the information was instead incorporated into the Briefing to IM to the Minister of Transport and may be used to inform future work.

Regarding Attachment 1, certain information is being withheld under section 9(2)(a) of the Act. This section allows for the withholding of information to protect the privacy of natural persons. Certain information in this document has also been under section 9(2)(g)(i). This section allows for the withholding of information to protect the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty.

## 3. Details of any and all current recommendations that are 'live'/being considered for changes re rail space risks

The Regulatory Systems (Transport) Amendment 2 consultation run by the Ministry of Transport in 2022 contains two recommendations for change in relation to rail space risks:

- Reactive investigation powers under the Railways Act 2005
- Removing time constraints in rail safety case application process.
