## Please note the following concerning the data contained in this spreadsheet:

- This data is provided from the road traffic crash database; Crash Analysis System (CAS) version 2.3.1

  Waka Kotahi NZ Transport Agency maintains CAS which is updated once a Traffic Crash Report (TCR) is received from NZ Police sometime after the crash. Data is limited to fatal crashes for the years 2013 to 2023 as recorded in CAS to date 8/05/2023.

  Data is limited to crashes involving drugs or alcohol.

  Drugs means cause 109 'Drugs proven' was a contributing factor to the crash.

  Alcohol above limit or test refused means cause 103 'Alcohol test above limit or test refused was a factor contributing to the crash.

  Alcohol below legal limit means the breath or blood reading was non-zero but below the legal limit.

  A crash, to be recorded in CAS must have occurred on a road. The CAS definition of a road is any street, motorway or beach, or a place to which the public have access with a motor vehicle, whether as of right or not e.g. a public care park.

  Due to the police reporting time frame and subsequent data processing there is a lag from the time of a crash to full and correct crash records within CAS.

  Fatal, Serious Injury and Minor injury crash report data is usually recorded in CAS within one working day of Waka Kotahi receiving it from NZ Police.

  Due to the Covid-19 pandemic, NZ had a 4-level Alert system in place from 21 March 2020 until this changed to a Traffic Light system from 3 December 2021 to 12 September 2022. The amount of traffic on the roads during level 4 lockdowns was greatly reduced, which consequently reduced the number of road crashes. Road movements under the Orange and Red levels of the Traffic Light system would also be reduced due to the restrictions in place, so date from these periods will not align with previous trends.

  The cause of a crash cannot necessarily be attributed to any one factor (eg drugs) as a crash may have multiple factors.

  Drug and alcohol factors for a fatal crash can be updated at a later date when Serious Crash utreports and Coroner's reports become available.

  Note that this is a table of road deaths involving a driver with alcohol or drugs. There are a few crashes where a drugged pedestrian or cyclist was killed but the driver had neither alcohol nor drugs in heir system. These are not included in the tab

- Total deaths involving alcohol and drugs in a crash means the alcohol and drugs could be different drivers or the same driver.

  A death can appear in more than one column of the table.

  From 1 December 2014 the breath alcohol limit was lowered to 250 micrograms of alcohol per litre of breath and the blood alcohol level was reduced to 50mg of alcohol per 100ml of blood. The previous limits were 400 micrograms of alcohol per litre of breath and 80 mg of alcohol per 100ml of blood.

  2022 and 2023 data is incomplete in CAS but the figures provided are what is currently in CAS as at 8/05/2023.

  Over time, crash numbers can change a tiltte either up (eg as late reports are entered) or down crash numbers can change a tiltte either up (eg as late reports are entered) or down can be excluded eg if a later Coroners report makes it clear that the crash was due to medical factors
