Request made under the Official Information Act 1982

Thank you for your email of 29 September 2023 to Te Manatū Waka Ministry of Transport requesting the information below under the Official Information Act 1982 (the Act). These parts of your request were transferred to Waka Kotahi NZ Transport Agency on 9 October 2023 as the information you are seeking more closely aligns with our functions. I will answer each of your questions in turn.

 I would appreciate any insights or information regarding Vehicle Ownership Data(in those two periods, in Upper & Lower North Shore and Auckland City area.), Traffic Congestion Data(in those two periods, in Upper & Lower North Shore and Auckland City area.)

On 10 October 2023, we advised you that we are unable to provide vehicle ownership data for the areas you specified, and that we only provide this data at a Territorial Authority Local Boards level. You clarified on 11 October 2023 that you are interested in Waitemata, Kaipātiki, and Upper Harbour Local Board areas.

Please refer to the attached document which contains data about vehicle ownership In the areas you requested. The data in the spreadsheet should be read in conjunction with the caveats on the first page of the spreadsheet.

You can also find vehicle ownership data on the Stats NZ website. The following webpage enables you to identify household car ownership by SA2 unit, which is slightly larger than a neighbourhood, but smaller than a suburb:
