### **NEW WALKING & CYCLING PATHS**

The draft alignment plan also includes a new 5km shared walking and cycling path alongside the Northern Busway and SH1 all the way from Oteha Valley Road down to Constellation Drive and then across and along SH18, joining up to the new cycle path on Albany Highway. It is envisaged the shared path would be similar to the popular Northwestern Cycleway on the Northwestern Motorway (SH16), Auckland Transport is also investigating what other routes could be prioritised in the area to form a comprehensive network. The first proposed connection will be the Spencer Road Bridge – a new pedestrian and cycle bridge across the motorway, connecting Pinehill and East Coast Bays residents with the Albany metro area and offering great views of Auckland City and Rangitoto Island.

### **BUSWAY EXTENSION**

It's now confirmed that the project will include an extension of the popular Northern Busway from Constellation Bus Station to Albany Bus Station. This means buses will be able to travel on a dedicated busway all the way to Albany reducing travel times and improving public transport options.

Auckland Transport is also investigating a new bus station and Park & Ride options in Rosedale along the new busway extension. As part of this, Auckland Transport will look at local road improvements and additional feeder services that could help transport people in and out of the station from

the East Coast Bays, North Harbour, and Rosedale. Similar to Smales Farm, it is expected that this station will be a destination station for the many people who work, go to schools or attend sporting activities in the area. It will also provide another station from the city.


HAVE YOUR SAY:

LOCAL ROAD IMPROVEMENTS

A central part of the project involves upgrading Upper Harbour Highway (SH18) to full motorway status and separating local roads from motorway traffic. This will improve journey times, safety and today's congestion issues. Both the Constellation Drive and Caribbean Drive intersections will be improved, including providing additional turning lanes and prioritising traffic light phasing to reduce queeing. A new bridge will connect Paul Matthews Road with on and off-maps to SHI8 and the new Caribbean Drive intersection. A second bridge is being investigated to improve connections for the Unsworth Heights residents. New pedestrian and cycle paths will provide a safe crossing point over these new roads and bridges, with the aim to encourage more people to walk, cycle and take public transport.

# PLANS FOR UNSWORTH HEIGHTS

As part of this project, the current local road connections to Upper Harbour Highway (SH18) at Caribbean Drive, Paul Matthews Road and Unsworth Drive will be separated from the new motorway and re-designed. The aim is to connect local roads across or under the motorway, and build a safer, more efficient layout.



## HAVE YOUR SAY... PROPOSAL FOR A NEW UNSWORTH DRIVE BRIDGE

A second bridge is also being investigated from Unsworth Drive over the motorway to Omega Street. The bridge has been proposed to provide an alternative access route into Unsworth Drive when the current one way entry point has to close.

Unsworth Drive used to cater for much more traffic than it sees today, because it originally had full access in and out onto Upper Harbour Highway.

If our ongoing investigations approve this bridge as part of the project, it could provide residents with better connections to and from the North Harbour area.

However, recent traffic modelling investigations have shown that the new connection will increase traffic volume along Unsworth Drive, including potential industrial traffic. A range of traffic calming techniques are being investigated and may need to be included.



# 뉴질랜드 정부는 오클랜드의 노스쇼어 지역에 대한 Northern Corridor Improvements 프로젝트의 다음 단계를 발표하였습니다.

이 프로젝트가 완료되면 Northern Motorway (SH1)와 업그레이드 된 Upper Harbour Highway (SH18) 를 직접 연결하는 도로가 완공될 것이며, 이는 Western Ring Route를 구성하는 마지막 부분입니다.

Northern Corridor Improvements는 Constellation Bus Station과 Albany Bus Station 사이의 Northern Busway를 연장하는 또 다른 유형의 이동 방법을 개선하게 되며, 지방도로 연결망과 보행로 및 자전거 길을 업그레이드하게 됩니다.

Auckland Transport는 현재 Rosedale에 추가적인 버스 정류장과 Park & Ride 옵션에 대한 조사를 하고 있고, 이는 앞으로 많은 직장인들에게 버스로 산업 지역으로 출근할 수 있게 할 것이며, 지역 학생들이 편리하게 North Shore 중앙 근처의 학교로 통학할 수 있게 할 것입니다.

이 프로젝트의 다음 단계는 2년간의 계획과 의견수렴 과정을 수행하며, 이는 2018년으로 예정된 건설 시점에 한 발 다가갈 수 있게 할 것입니다.
