1	Individual	SH90 Tapanui	We live at the Gore side of Tapanui at the foot of the hill warning traffic to slow down for 50k restriction.  Notice speed up and down hasn't changed with new signs. Very aware of traffic coming down hill at speed.  Suggest residents fence their sections for their safety.
2	Individual	SH90 Tapanui	You would be better to change the speed at the other end of Tapanui where the golf course is! I don't know of any accidents at that entrance into town. I've had more crashes on my farm on the Tapanui bypass road which is a joke with the traffic islands they put in, I offered land on my farm so they could move the road a bit to help make it safer but they said no, so they can get fucked now as I've put a new expensive fence up there now. I know there's another reason why they want this speed change and it's not for safety

7	Individual	SH90 Tapanui	Thank you for the opportunity to make submission on proposed extension of the 50km zone. I firmly believe that no change is required, as I contest that any problems are strictly that of compliance, if traffic is doing 50km at the correct point. There simply is no problem. The current position is perfect as the incline allows for the easy deceleration. This proposed could be likened to reducing the open road speed to 80km the hope that traffic would not exceed 100km. Also, there is no housing development. to the west of proposed new 50km zone.
8	Individual	SH90 Tapanui	Thanks for allowing comment. I am against extending the 50km/h zone as the current zone is fine if adhered to. My preference would be to have a 70km/h limit at the proposed 50km/h extended limit, this would have the driver reducing speed well before the 50km/h sign. I have found with extensive driving in NZ and overseas that a graduated speed limit is much more user friendly and more likely to be adhered too.
9	Individual	SH90 Tapanui	Firstly, I would like to ask who the community is you have spoken to - I have not seen a meeting advertised reporting this submission. Secondly the cars have not slowed down at all with putting a 50km sign on entry to Tapanui. I believe only policing will maybe make a change. In my opinion it should be 70km at the bottom of the hill entry into the 50km/h zone, and another 50 km/h sign around the lower end of Dorset Street so cars exiting Tapanui aren't doing 100 from around 21 Dorset street only ones who benefit are the business on the exit of Tapanui township on the books only. So, by making it 50km/h it sounds and looks safer for cars entering the business. I am a resident close to this sign and fear for children and animals of which cars on the road exiting Tapanui township find it very hard to slow down. I have emailed Transit for 6 years and never heard back from them. Please read and listen to the submissions so we can make is safe for everyone. I am willing to talk in person.

35	Individual	SH90 Tapanui	All for a speed reduction on this piece of road. What about also considering and introducing a limit on the north end of town past the health centre, college and play centre. Many motorists seem to think a 50km/h sign means they have to travel at that speed! Goodluck!
36	Individual	SH90 Tapanui	The proposed change will only take in the double driveway at the bottom of the hill. There are three more business entrances beyond there, towards Gore (Gardens Gate, Vet Clinic and Stuarts)  It would make better sense to me, to create a 70km/h zone, from the current 50km/h zone, to about the corner of Duncan road, thereby including the above m entrances, as well as a safer intersection at Duncan Road.  Even an 80km/h upper limit would be safer than what is currently in place, and most drivers will comply with a reasonable upper limit such as 75/80km.

The following is the feedback that I have received from the District in relation to the Speed Reviews:  New Zealand Police strongly supports safe driving speeds and this includes the setting of safe and appropriate speed limits. The NZ Transport Agency's proposed changes to speed limits on State Highway 1 sections in Balclutha, and Taupo Airport to Turangi, and State Highway 90 Tapanui are better aligned with safe and appropriate driving speeds on these sections of roads. There is good evidence that this will improve the safety of all road users on these road sections. Police supports the NZTA in improving road safety through appropriate speed management and continues to work alongside NZTA and other road safety partners to prevent trauma on our roads.

We live further down the road on SH90 and are well-aware of the speed vehicles travel right up to the 50km/h sign that's in places at the moment. Prevention is far better than a fatality

59	Individual	SH90 Tapanui	Having received the Safer Speed Review Consultation Form, I wish to submit my concerns. As I have lived in the township for 55 years, Please consider my views.  As a Great Grandfather of 2 families on that stretch of highway, it concerns me very much as to the speed of most vehicles in the disputed stretch of road. We have stipulated very much to the younger children, that they do not even play on the footpath. No one knows when a car is going to veer off the highway or out of control or when cars are passing each other at speed. Accidents are waiting to happen. The area of concern is now being developed for housing and the occupants cars have the right to enter and depart in a safe manner. The 50 km/h being at the top of the hill does not slow most vehicles down. I agree in shifting the 50 km/h 200m south towards Gore. And the same goes to vehicles going out of southward, including heavy trucks weighing now 45 plus tons start winding up their speed outside the Police Station and when they reach the disputed stretch of highway they are at top speed and more. I understood that Duncan Road was a designated road for all heavy trucks; I believe that most of Fontera trucks do take that road as there is a transfer station further down Station road. But there still is quite a number of heavy trucks going and coming through the township. As for the south end of the township I urgently request that something has to be done. Weekends and after hours are extremely of concern as for the speed, they should go down to Teretonga raceway In Invercargill. While I'm in the mood the speed past the Blue Mountain College and the West Otago Health and Ribbon Wood Rest Home in the northern entrance to the township. Attention is badly required there before someone is killed. I am aware that I have extended my write to you past the area of concern, But that's the way it is, I'm just giving you a broader view to the problems in this area. 62	Individual	SH90 Tapanui	I think you should make the proposed change to 70 km/h I feel changing the limit to 50 would be overkill. I am also disappointed to see your diagram is mis-leading. The speed sign is on the western side of the vehicle service centre, not the eastern side as your diagram indicates. This will skew people's opinion and will compromise the integrity of your feedback. There are no houses or shops immediately after the existing 50 km/h signs therefore the 70km sign I propose will act as a buffer to allow people time to slow down. I also think there should be a 70km buffer 200m down Station road from the 50km sign as the current 50km sign is on a corner with limited visibility which presents a major hazard for residents.
63	Individual	SH90 Tapanui	This change makes a lot of sense.  However, the other factor to consider is the 250m 'grace' distance given to drivers entering a 50kmph zone from a 100kmph zone.  This means, as witnessed daily in all rural townships like Heriot and Tapanui, that even with this positive change we will continue to see dangerous and excessive speeds legally travelled within our 50kmph zones. In my opinion there are only two ways we can address this:  Firstly is with a law change to permit prosecution of offenders which will over time modify behaviour. Secondly is with aggressive traffic calming measures such as narrow spotting or speed humps.  Until we address the issue of this legal 'grace' period within our 50kmph zones all we are doing with this proposed change is moving the problem a little further down the road and not achieving much at all.
