

New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2013/3

Pursuant to section 61(3) of the Government Roading Powers Act 1989, section 22AB of the Land Transport Act 1998 and the Land Transport Rule: Setting of Speed Limits 2003, the NZ Transport Agency hereby makes the following bylaw.

Bylaw

1. Title and commencement-

This bylaw may be cited as the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2013/3 and will come into force 28 days after the date of publication of this notice in the New Zealand Gazette.

At all other times the speed limit is 100km/h."

- Inserting new line in Schedule 2 to read:

"Section of State highway: The section of State Highway 25 (Thames Coast Road) at Te Puru School from 290m north of Te Puru Creek Road to 670m north of Te Puru Creek Road.

Speed limit: Any time during any period specified in condition 2 of the School Zones Notice when a variable speed limit sign installed on the section of State highway displays the numerals "40", the speed limit is 40km/h. At all other times the speed limit is 50km/h."

- Inserting new line in Schedule 2 to read:

"Section of State highway: The section of State Highway 26 at Newstead School from 860m north-east of Ruakura Road to 1.16km north-east of Ruakura Road.

Speed limit: Any time during any period specified in condition 3 of the Rural Schools (Turning Vehicle Hazard) Notice when a variable speed limit sign installed on the section of State highway displays the numerals "60", the speed limit is 60km/h. At all other times the speed limit is 80km/h."
