## Transit New Zealand (National Roads Board Bylaws Revocation) Bylaw 1995

## Explanatory Note

This note is not part of the bylaw, but is intended to indicate its general effect. This bylaw revokes bylaws that are no longer appropriate for various reasons, including in some cases that the road concerned is no longer a State highway or that the road has been realigned.

National Roads Board Bylaw 1985/1 related to the use of certain vehicles on that portion of State Highway No. 5 known as Pohokura Road.

National Roads Board Bylaw 1985/3 related to heavy vehicles on State Highway No. 38 between Waiotapu and Wairoa.

National Roads Board Bylaw 1983/1 related to State Highway No. 89, closure of the Crown range in winter conditions.

National Roads Board Bylaw 1963/2 related to traffic on West Taieri Bridge on State Highway No. 87.

National Roads Board Bylaw 1961/2 related to movement of cattle on the lower Shotover Bridge on the Blenheim-Invercargill State Highway and on the Cromwell Bridge on the Timaru-Milton State Highway.

National Roads Board Bylaw 1955/1 related to heavy traffic on the Kawarau, Victoria, Shotover and Beaumont Bridges on the Milton-Queenstown State Highway.
