Development of investment assurance programme

The Investment Assurance Programme provides assurance to the Transport Agency that its investments in Approved Organisations and the state highway network are being well managed and providing value for money outcomes.

The programme consists predominantly of investment audits and post implementation reviews. Other assurance work, such as theme audits, may also be done on an ad-hoc or as required basis. One theme audit is planned for 2017/18.

Each approved organisation will be advised at least one month in advance of an audit or review commencing.

Procedural investment audits provide assurance that the NLTP investment in approved organisations' and state highway land transport programmes is being well managed and delivers value for money outcomes. Technical investment audits provide assurance over approved organisations' and state highway activity management planning, adequacy of data used to assess network quality, value for money, and safety and network management.

B. NZ Transport Agency - Service Design and Delivery (formerly these were audits of HNO regions and national office functions)

The Transport Agency was in the process of undertaking a major transformation of its organisational structure and operating model at the time this general circular was prepared. Previously, investment audits assessed functions and operations performed by the Highways & Network Operations (HNO) group. Many of these functions will be done by the new Service Design and Delivery group under the new organisational structure. But this will be confirmed and/or amended as required during 2017/18 before the following audits are carried out.

2. Post implementations reviews planned for 2017/18

A new approach for doing post implementation reviews will be used in 2017/18. The reviews have previously assessed how well projects had delivered all their main expected benefits (including travel time and safety outcomes), with explanation of variation between actual results and expected benefits and costs.

However, there is a practical difficulty with selecting the optimal time to do a post implementation review of a completed project. Travel time related outcomes can be assessed almost immediately (and before other changes in the local network might affect observed results). In contrast, assessment of safety effects requires several years of crash data before reliable conclusions can be made about observed trends.

To overcome this review timing difficulty, the revised approach planned for 2017/18 will be to separately evaluate:

- travel time related benefits for several recently completed major projects (including some which have not been completed yet but will be later in 2017), and
- safety outcomes of projects which were previously reviewed but where it was either too soon after completion to properly analyse crash trends or safety concerns were raised.

In addition, it is also planned to review the benefits realisation of a sample of recently completed cycleway projects.

C. Cycleway project reviews

Several cycleway projects have been completed in the past two years. This reflects a boost in government funding for these types of projects. A sample of completed cycling projects will be

reviewed in 2017/18 to cover a regional spread around the country, and a mix of urban and non-urban projects.

3. Theme audit for 2017/18

Theme audits seek to address a specific topic that is common to or affects many approved organisations.

Road safety audits – investment audits and post implementation reviews have found limited adherence to road safety audit requirements. These audits are a funding condition for capital improvements. They are designed to identify any potentially serious issues with a project's design or build which might generate safety problems. They should be done at critical stages of a project's life cycle unless an exemption is granted.

The purpose of this theme audit will be to:

- assess the extent of this apparent lack of adherence to road safety audit requirements across a sample of approved organisations,
- identify any common or systemic reasons for non-adherence, and
- recommend any mitigation measures required to address identified issues.
