Purpose

To advise Approved Organisations and other relevant parties of the Waka Kotahi (NZ Transport Agency's) programme of investment audits planned for the 2023/24 financial year. The audits will be carried out in accordance with the sub-section 95 (j) (ii) (iii) of the Land Transport Management Act 2003.

Development of Investment Audit Programme

The Investment Assurance Programme provides assurance to Waka Kotahi that its investment in Approved Organisations is being well managed and provides value for money outcomes. Other assurance work, such as theme audits, may also be carried out on an ad-hoc basis. Waka Kotahi Risk and Assurance Committee approved the Programme on 18 May 2023.

The 39 authorised audits listed by region in the Programme have been selected based on:

- Date of previous audit
- Previous audit outcomes
- Quantum of money received through the NLTP
- Complexity of transport network
- Staff capacity and capability and any significant internal and external changes since last audit
- o Cyclone Gabrielle Emergency Works first response.

INVESTMENT ASSURANCE PROGRAMME 2023/24

Investment Audits planned for 2023/24 are themed, procedural, or technical in their focus.

Themed investment audits will be completed by the Procedural team only and will focus on the North Island Weather Event (NIWE) special FAR funded organisations and will provide assurance that the approved one-off special funding assistance meets the requirements. This includes immediate response activities completed before 30th June 2023.

Procedural investment audits provide assurance that Waka Kotahi NLTP investment in Approved Organisations' meets the requirements and delivers value for money. The Procedural audits are typically conducted in a three yearly cycle, with the large investments audited every one to two years. The Programme includes a review of public transportation management and validates patronage funding claims, concessionary fare schemes, and Total Mobility schemes.

Technical investment audits provide assurance that Waka Kotahi NLTP investment in Approved Organisations' meets the requirements and delivers value for money. The technical audits assess the network condition and management, activity management planning, data quality, and road safety. The key selection criteria comprise risk related to network complexity, resourcing, investment levels and time since the last audit. The technical audits are conducted on average every six years.
