# Foreword

Most aspects of Transit New Zealand's business require accurate and consistent referencing to the State Highway network. To do this Transit New Zealand has used a linear referencing system. However, with the present demands on reliable location data for analysis and management, particularly in computer databases, it is becoming increasingly difficult and costly to manage. The complexities of multi-lane environments and the use of automated data collection devices (SCRIM, High Speed Data) add to the difficulties of locating data on a dynamic network.

This led to the Location Referencing Management System (LRMS) Project, which included:

- The upgrade of the location referencing method (spatial and linear).
- Enhancements to the management procedures to provide a more accurate and consistent referencing system over time.
- Implementation of an improved method and procedures along with the software 'Highways by Exor' for network management.

The previous location referencing system worked well but was not always applied in the correct or consistent manner. Therefore refinements have been made to the location referencing system and a new management process has been introduced to provide quality assurance. This includes controls to ensure that the required work is done at the correct time and in the correct manner.

Transit New Zealand appreciates the input from many interested parties and also thanks the project team comprising HTC Infrastructure Management Limited, MWH New Zealand Limited, Scott Wilson (UK), Africon (South Africa), CJN, Exor and Beca Carter.

This document replaces the current Distance Marking Manual (SM051). It is intended to tie together all aspects of location referencing. To achieve this it looks at the three major elements of the LRMS:

- The Location Referencing Method
- The Location Referencing Procedures
- The LRMS Software.

It also cross-references relevant proforma and maintenance specifications to provide a "one-stop-shop" for location referencing.
