

LAND TRANSPORT RULE REGULATORY STEWARDSHIP (OMNIBUS) AMENDMENT 2019

Changes to Land Transport Rules

18 APRIL 2019

The Associate Minister of Transport, Hon Julie Anne Genter, has signed into law amendments to 15 Land Transport Rules.

The changes are relatively minor amendments that do not incur any significant costs or impose any regulatory burden.

The amendment Rules were included in a single Land Transport Rule: Regulatory Stewardship (Omnibus) Amendment 2018 for consultation. Public consultation on the proposals commenced in July 2018. The NZ Transport Agency received 41 submissions on the proposed Rule changes from groups, individuals and government agencies. These submissions were considered in finalising the amendment Rules.

When do the amendment Rules come into force?

The 15 amendment Rules come into force on 1 June 2019.

Why have these amendment Rules been made?

These changes are necessary for a variety of reasons, including:

- clarifying or modifying current requirements to support understanding and enforcement
- amending requirements or removing unnecessary or unintended requirements to reduce the burden of compliance (without lessening safety standards)
- · amending requirements to be consistent with current practices and technology
- correcting errors in cross-references, descriptions and technical specifications in current Rules.

- Land Transport Rule: Vehicle Equipment 2004

- Land Transport Rule: Vehicle Standards Compliance 2002
